2. Regular Meeting 2022-08; August 24, 2022

NEW BUSINESS:

1. Selection of a new Board Chair

Ms. Ziegler motioned to nominate Mr. Snyder as Chair. It was seconded by Mr. Luse. Motion carried unanimously.

2. Discussion on Voluntary Low Impact Development incentives matrix

Ms. Ziegler explained she was supportive of the current matrix. She requested a definition of what a "best management practice" was. She went on to say how certain methods in other parts of the country would not be applicable in Florida. Lastly, she was interested in revisiting the matrix after implemented to see what ends up being the most discussed/popular incentive.

Mr. Luse explained his background in agriculture. He is supportive of the matrix as it stands currently. He would like some focus to be placed on drainage systems.

Mr. Smith is supportive of the matrix. He would like to see how effective current incentives in other places are. He would also like to see how data may be obtained in order to determine which incentives are most successful.

Mr. Snyder is supportive of the current matrix. He wanted to see if there was a plan to make revisions to it after it is adopted. Ms. Sherman noted that it would be revisited to see how effective the incentives are once implemented.

3. Authorize Vice Chair Snyder to address the Palm Bay Municipal Foundation regarding the creation of a Sustainability Fund

Ms. Ziegler motioned to authorize Mr. Snyder to address the Palm Bay Municipal Foundation regarding the creation of a Sustainability Fund. It was seconded by Mr. Luse. Motion carried unanimously.
