

1. FPL Solar Program – Michele Murrell, FPL External Affairs

Daniel Brankin and Michele Murrell, Florida Power and Light (FPL), gave a presentation on FPL's clean energy practices. the near future, such as the "Real Zero" goal that involved decarbonizing their power plant fleet by 2045. Mr. Brankin and Ms. Murrell responded to questions posed by board members.

2. Sustainability Fair Updates

Ms. Suros provided a list of vendors and organizations that had expressed their interest in participating in the fair. She confirmed demonstrations that were on the agenda for the fair which included a rain barrel workshop and discussions about home gardening and composting by Kay Maragh.

Motion by Mr. Smith, seconded by Ms. Higgins, to add an update to electric vehicle progress by the city at the March 2023 meeting. Motion carried unanimously.

OTHER BUSINESS:

1. Upcoming meetings/events of interest (INFORMATIONAL)

Board members discussed events happening in Palm Bay in the upcoming month, which included Trash Bash 2023 on April 1st, starting at 8 a.m., at selected collection sites. Registration for volunteers would be processed through Ms. Suros.
