### 1. Sustainability Fair discussion and overall outcome

Mr. Snyder opened the discussion with requesting board members to list items they wish to continue in upcoming fairs. A consensus was made for using matching t-shirts to be recognizable by others at the fair. Also, having workshops, and tents for Utilities and Republic are favorable and will be requested in the future. Things to improve on would include obtaining more food trucks, better garbage and recycling control and/or attempt to be a zero-waste event, and lastly striving to have more focus on vendors that have clear links to sustainability.

The Board discussed trying to have a raffle at next year's event, forming a sub committee and starting to plan a lot sooner for the event, and lastly gave some new ideas for workshops and demonstrations.

### 2. Native plant demo garden update

Ms. Higgins noted that the Conradina Chapter of the Florida Native Plant Society is interested in helping fundraise for the garden. She added the group did need more information before making a decision to proceed. Comments closed with Ms. Sherman mentioning a follow up meeting with city staff would be needed.

# 3. New goal(s) for board to pursue

Mr. Snyder opened the discussion asking each board member to discuss a topic of interest to focus on. Each member agreed on trying to establish a composting program within the city. Comments were made to educate and follow up on HOA's in Palm Bay and the rules and regulations they have.
