The meeting was called to order at the hour of 7:33 P.M.

# PRESENTATION:

# 1. Dina Reider-Hicks, Public Affairs Manager, Waste Management – Palm Bay Solid Waste and Recycling Services.

Ms. Reider-Hicks reviewed the components of recycling, what made something recyclable, what happened to recyclables at the facility, and the facts about recycling. She advised that recycling contamination (the percentage of trash mixed with recyclables) had increased and was jeopardizing the global recycling industry. Approximately 500 pounds of every 2,000 pounds collected at the curb was ultimately discarded as non-recyclable. She answered questions posed by board members.

# 1. Discussion of Core Element, Objectives and Action Items: Natural Environment.

The Board concurred Each board member presented their ideas related to land and water. Topics of discussion included Turkey Creek; preservation of natural areas; state regulations on septic tanks; reduction of septic tanks and expansion of services for sewer toward businesses; management and protection of groundwater and surface water bodies; plan for adaptation to sea level rise and dynamic climate conditions; implementation of native plants in city facilities; reduction of fertilizer use; reduction of wasted irrigation use; City composting programs; hydration stations (encouraging reusable water bottles); rain barrel workshops/leak detection and repair classes; special plants/tree placement in subdivisions; rain gardens; and a City plan that created places for green/wildlife corridors and community gardens.

The Board requested that staff present the following at future meetings: zoning/land use; greenhouse gas inventory; and mowing of City properties.
