NEW BUSINESS:

1. Pre-Storm Preparations – Keith Heinly, United Way of Brevard.

Mr. Heinly said that United Way had significant disaster related responsibilities in the event of the storm. The team members worked at the Emergency Operations Center (EOC) assisting 2-1-1 with answering hotline calls. They were also actively involved at the request of the EOC staff in coordinating potential water distribution as well as coordinating, recruiting and placing volunteers to help with many aspects of disaster response. Mr. Heinly further explained how United Way assisted during disasters and the current pandemic. He said that, typically, shelters would be available, but due to COVID-19, additional shelters had to be opened in order to provide more space. He answered questions posed by board members.

Ms. Valcin-Bowes asked how students could develop a team and would they receive community hours for same. Mr. Heinly answered that developing a team was easy, but other requirements such as proper training, liability insurance, and background checks had to be done. He preferred that unaffiliated groups join teams that were already established due to volunteer liability reasons. He provided information on training and contacts for same.

2. Cool Cops – Chief Nelson Moya, Palm Bay Police Department; Elena Little, Club Esteem.

Chief Moya and Ms. Little were unable to attend the meeting. Deputy Mayor Johnson explained that pursuant to the Board's direction, the City launched the Cool Cops Program in collaboration with Club Esteem. It was a mentoring program in which police officers met with youth in the community every Friday, connecting and fostering relationships, and encouraging the teens to seek employment in law enforcement.

3. Consideration of scheduling meetings dates/times for the board.

Mrs. Jones suggested the 3rd Monday or Tuesday of each month. She would send an email to the board members to confirm same.

OTHER BUSINESS:

- 2. Military Tribute Banners (Board Member Stokes) Mr. Stokes presented the item to the Board. He said the banners were a way to honor those who had served or were currently serving our nation. City staff supported the program and would coordinate with the Florida Power and Light for approval to utilize light poles. He proposed that the YAB

Florida League of Cities Announces Municipal Youth Council Community Service Contest Winners

Alachua, Niceville, Tampa, Wellington and West Park youth councils recognized for volunteer service projects

TALLAHASSEE, Fla. – The **Florida League of Cities**, the united voice for Florida's municipal governments, today announced the winners of the 2020 Municipal Youth Council Community Service Contest. Hosted annually, this contest showcases community service projects performed by municipal youth councils that successfully address specific needs in their local communities.

Composed of high school students within the city, municipal youth councils are special councils that typically serve as an advisory board to the local government. They are sometimes referred to as youth corps, teen advisory boards or mayor's youth councils.

"I'm passionate about engaging youth in the work of local government, and municipal youth councils are an excellent way to do that," said **Florida League of Cities President Isaac Salver, council member** for the **Town of Bay Harbor Islands**. "These students are the next generation of civic leaders, and if what we've seen from youth councils throughout Florida is any indication, our future looks incredibly bright. On behalf of the League, I congratulate this year's award winners."

This year's contest winners and their projects are:

- City of Alachua Youth Advisory Council "Election Education for Youth."
- City of Niceville Youth Advisory Council "Twin Cities Pavilion Parade."
- City of Tampa Mayor's Youth Corps & Leadership Council "Cyrus Greene Community Center Tutoring Program."
- Village of Wellington Youth Council "Helping Youth by Providing Empowerment."
- City of West Park Youth Council "COVID-19 Food Give-A-Ways."

The **City of Alachua Youth Advisory Council** launched the "**Election Education for Youth**" project to help educate local students about elections. To do this, they setup information booths at high schools within the city where they engaged with students directly to talk about elections and answer questions. They also provided information on local, state and federal elections, voter registration and the election process overall. The goal of the project was to help young or soon-to-be voters be better informed and more civically engaged.

The "Twin Cities Pavilion Parade" project from the City of Niceville Youth Advisory Council was a community event focused on supporting the senior citizens of Niceville during the COVID-19 pandemic. For the event, the council recruited volunteers to participate in a drive-by vehicle parade and collected letters and cards to give to the senior residents. The result was a parade of more than 50 vehicles, all decorated with signs and banners offering words of encouragement, dozens of letters with well wishes and positive messages, and a group of senior citizens whose spirits were dramatically lifted.

Through their "Cyrus Greene Community Center Tutoring Program," members of the City of Tampa Mayor's Youth Corps & Leadership Council tutored local elementary and middle school students. During the school year, the council volunteered four days a week at the Cyrus Greene Community Center where they helped students with everything from writing assignments to long division math problems. The council's goal for the program was to not only help educate these students, but also to inspire them.

The "Helping Youth by Providing Empowerment" program from the Village of Wellington Youth Council was designed to provide academic support to local elementary and middle school students. As part of the program, the council created "HYPE (Helping Youth by Providing Empowerment) Hall," which serves as a place for the village's youth to do homework, prepare for tests, complete group projects or even play board games with other children. The council's goal for the project was to create a safe and welcoming place for local students. The program is proving to provide an important service to the community.

The **City of West Park Youth Council** worked with city leaders, the local Broward Sheriff's Office District and Feeding South Florida for the "**COVID-19 Food Give-A-Ways**" project. After noticing that the community needed help accessing food during the COVID-19 pandemic, these groups joined forces to host free drive-through food distribution events. So far, they've hosted eight events and provided almost half-a-million pounds of food.

Contest winners will receive a trophy, be featured in the League's award-winning magazine, *Quality Cities* (*QC*), and have their projects featured on the League's website and social media accounts.
