ADOPTION OF MINUTES:

NEW BUSINESS:

1. Discussion of proposed Sustainability Action Plan.

The Board concurred with the following additional revisions to the plan under the category of Natural Environment (Land and Water Systems):

- Objectives; Goal 2; City Government objectives include (E) to read as follows: "Identify City-owned property suitable for planting large trees generally undesired on small residential properties. For instance, where there are retention ponds or low lying seasonally wet areas, consider planting native Pond Cypress or Bald Cypress."
- Objectives; Goal 2; Community objectives include (C) to read as follows: "Encourage the replacement of turf grass under the canopy of larger trees with understory trees, shrubs, and groundcovers, which stabilizes the largest trees during high wind and rain events."

The Board noted that this objective could be added to the educational section.

The Board concurred with the following additional revisions to the plan under the category of Energy and Buildings (Built Environment):

- ➢ Goals 1, 2 and 3 would be revised as follows:
 - Goal 1: Promote and support sustainable infrastructure and green building standards.
 - Open space/Walkability and Connectivity;
 - Systematically upgrade existing buildings, equipment and infrastructure
 - Goal 2: Reduce Greenhouse Gases (GHG)
 - Goal 3: Transition to clean and renewable energy
- Additional language would be added to Objectives to read as follows: "Objectives: To create sustainable cities that are inclusive, safe, resilient and sustainable by implementing green building policies and programs, transitioning to clean renewable energy, and reducing energy consumption and greenhouse gases."
- Goal 1; Local Business objectives language would be added to (B) to read as follows: "Consider pedestrian safety in parking lot design such as greenways (walkways bordered by trees and shrubs) or elevated walkways for visibility."

- Goal 2; Community objectives should be consolidated or added to Local Business/Community objectives.
- Goal 3; Local Business objectives (C) to read as "Allow >>Promote<< on-site energy generation (e.g., ground source heat pumps or other district clean energy source, or on-site solar generation).
- Goal 3; Community objectives (B) add language encouraging lighting for safety and addressing areas that could use more lighting to make residents feel safe and reduce light pollution.
- ➢ Goal 3; Community objectives add (C) to read as "Encourage solar co-ops".

Ms. Ford asked that Honeywell provide a presentation at the next meeting.

The topic for the next meeting would be Transportation and Mobility.

OTHER BUSINESS:

1. Ms. Sherman advised of a Turf Swap Program that was developed in Alachua County. The purpose was to support replacing turfgrass with Florida-friendly landscapes. She advised that this could be a future presentation if desired by the Board.

2. Mrs. Jones announced that the next meeting was scheduled for Tuesday, September 29th, at 7:00 P.M.
